Re: National "Slow Down" Day – 7.00 hrs Friday 28th August to 7.00 hrs Saturday 29th August 2015.

An Garda Síochána will conduct a national speed enforcement operation "Slow Down", supported by the Road Safety Authority and other stakeholders for a 24 hour period from 07.00 hrs on Friday 28th August to 07.00 hrs on Saturday 29th August 2015.

Last year saw another increase in road deaths, resulting in 195 fatalities. Excessive and inappropriate speed is a major contributory factor to road traffic collisions. The higher the speed, the greater the likelihood is of a collision happening and the more severe the outcome of that collision. As a general rule a 1% reduction in average speed will bring about a 4% reduction in fatal collisions, and this is why reducing motorists' speed is essential to improving road safety.

The objective is to reduce the number of speed related collisions occurring and therefore save lives and reduce injuries on our roads. The aim of "Slow Down" is to remind drivers of the dangers of speeding, increase compliance with speed limits and act as a deterrent to driving at excessive and inappropriate speed.

The operation will consist of high visibility speed enforcement activities as well as the delivery of a road safety message through the use of national and local media. In addition,

Garda personnel will man display stands in key venues where personnel can provide road

safety advice and distribute road safety leaflets.

I am seeking your support for this initiative by circulating all employees and contractors,

through all communication mechanisms open to you, including internet, intra-net, and social

media, with the key message to "Slow Down" and, whether driving for business or private

purposes, to always drive within the speed limit and at a speed appropriate to the prevailing

conditions.

Drivers are also asked to turn dipped headlamps on to show support and increase their

visibility.
